

# BATHING ESTABLISHMENT REGULATIONS

These regulations are posted in the sporting facility and govern its use. They are assumed to be known and accepted unconditionally and wholly by all users having entitlement to access.

**The ticket of admittance is a non-transferable receipt and its validity expires on leaving the facility;** it must be shown on request by staff. Anyone found without a ticket will be required to pay for a new admittance.

Passes entitle the holder to a number of admittances. They are strictly personal and, if transferred to others, will be void. They must be shown and, on request, handed in to the reception of the facility.

**Passes for covered swimming pools do not give right of entry to the Bathing Establishments and open air pools (Argelati - Cardellino - Lido - Romano - Saini - S.Abbondio - Scarioni)**

**During the hours of opening to the public, children under the age of 14 may enter the facility solely if accompanied by a parent or other adult in possession of an identity document, who shall become legally responsible on signing the waiver.**

**Milanosport, at its complete discretion, for reasons of force majeure and/or bad weather reserves the right to:**

- proceed to close the ticket offices, at the same time prohibiting users present for whatever reason to enter the pool. On occurrence of this condition no refund will be due;
- proceed, in exceptional circumstances, to the closure of the facility, obliging all users present for whatever reason to leave the premises. On occurrence of this condition the users may be entitled to use their ticket on another date if they have used the service for less than 60 minutes.

**The personnel reserve the right to:**

- refuse entry to or expel those who disturb public order and morality or in any way, by disorderly conduct, dangerous games or other behaviour which may jeopardise the good running of the activity;
- not allow, for reasons of health and hygiene, entry into the water by persons affected by infectious diseases or who exhibit skin lesions or wounds.

Users sent away from the facility for the above reasons shall not be entitled to any refund of money paid for admission.

Users must change in the cubicles and/or changing rooms provided, using them for the time strictly necessary without leaving clothing or personal effects. These may be deposited in the lockers provided, where present and according to availability. Where lockers are used it is indispensable for users to equip themselves with their own padlock, leaving the locker empty after use.

Staff on duty are authorised, at evening closing time, to open those lockers that appear improperly used at the end of activity.

**Staff will not accept liability:**

- for valuables, money and objects of value left in lockers or in the changing rooms even if locked, since these are to be placed in the "security safes" available to users for this purpose or in similar alternative facilities;
- for valuables, money, objects and any other material, with or without value, left inside changing rooms, even if locked.

Equipment, objects of value and bulky objects, will not be accepted or looked after by staff for any reason, unless otherwise instructed.

**It is obligatory to:**

- wear a bathing suit/trunks to enter the water
- shower before entering the water
- access the poolside wearing clean clogs or slippers in synthetic material
- wear a bathing cap when in the pool
- use enclosing swimsuits for children under 3 years of age and for physiologically incontinent users
- swim following the direction of the lanes, where present, to avoid disturbing other swimmers
- use the bins provided for refuse of any kind, respecting the refuse type where indicated

**It is prohibited:**

- to introduce objects of glass or other material that could be a danger to oneself or to other persons or things
- to wear prescription glasses, sunglasses or swimming goggles in the pool, except those with unbreakable lenses
- to introduce radios, sound reproduction equipment etc.
- to chase, push or create dangerous situations for oneself or others
- to run on the poolside
- to occupy in any way the areas reserved for the Swimmer Assistants
- to occupy the poolside, as bounded by fixed barriers along obligatory passages, with deck-chairs, sun beds or other large objects
- to occupy the lanes reserved to Milanospport athletes and course participants
- to bring dogs or other animals into the facility, even on a lead
- to smoke, as per law 03/2003 and any changes to the relevant laws, in force at the time of reading these regulations
- to consume food or drink in the water, on the poolside and in the changing rooms
- to shower without a costume or remove it in the common areas visible to the public
- TO ORGANISE INDIVIDUAL OR COLLECTIVE CLASSES, EVEN IF FREE OF CHARGE

**It is also prohibited, except where otherwise authorised:**

- to dive with run-ups, dive backwards, with somersaults or in any dangerous manner
- to swim in apnea
- to play with a ball in the water or on the poolside
- to use underwater fishing equipment including flippers, face-masks and other cumbersome objects such as arm attachments in rigid material
- to take photographs or to film
- to post flyers, posters and advertising material

THE RULES FOR THE USE OF WATER SLIDES, WHERE PRESENT, ARE GOVERNED BY SPECIAL REGULATIONS WITH SPECIFIC RULES, DESCRIBED AND ILLUSTRATED

The apparatus and other material making up the equipment of the facility must be used with proper care, conserved in full working order and replaced in an orderly fashion. Any ascertained damage to equipment and material will be charged to those responsible.

Milanosport will not accept liability for any damage to persons or objects, even where caused by users, as a result of improper use of areas, materials and equipment.

Knowledge of these regulations, as defined above, shall exonerate Milanospport from all and any liability.

Users are required to strictly follow these instructions and any that may be given by staff on duty.
